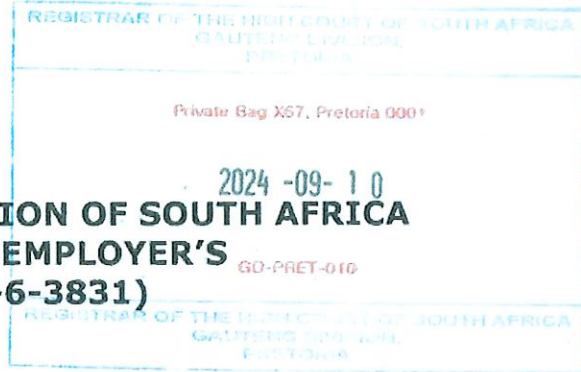

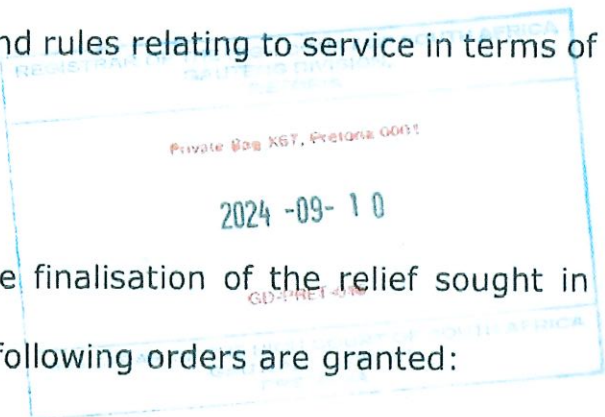

2.1 For an order reinstating the following expired qualifications:

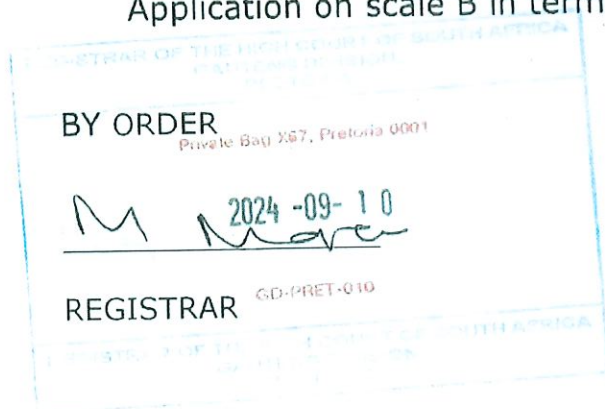
- 2.1.1 General security practice, qualification 58577 and all electives and related skills programmes that form part of or fall under this qualification as recognized by the Third Respondent;

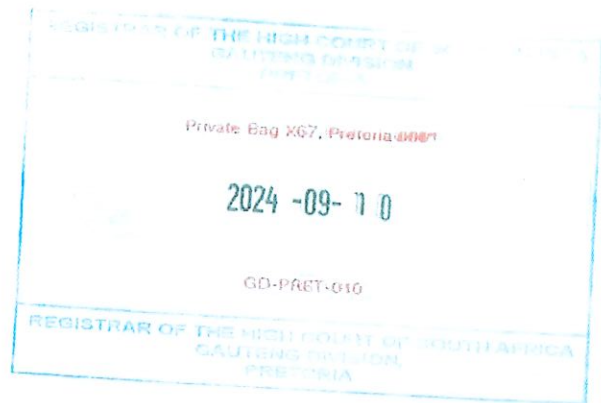
